Support data	Bids should include a product brochure from the manufacturer with technical specifications clearly shown.
Delivery of goods	Once taxes are cleared, the motorbike will be delivered to Uganda Wildlife Authority head office on Plot 7, Kira Road, Kampala.
Payment terms	60% on contract signing. 40% on satisfactory delivery of items to the address above. Late deliveries may be subject to a reasonable penalty.
Tender detailed background information	Uganda Conservation Foundation has received funding from the European Union (via CITES MIKES) to support Cross Regional Wildlife Conservation in Eastern and Southern Africa and the Indian Ocean. This project aims to support Uganda Wildlife Authority (UWA) to develop their human and equipment capacity to enforce law and order in Queen Elizabeth Conservation Area. The procurement of one Yamaha 125 motorbike is part of the larger programme across the whole protected area.
